

**CITY OF SHUEYVILLE  
ORDINANCE NO. 105**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE  
CITY OF SHUEYVILLE, IOWA, BY AMENDING CHAPTER 6,  
POSTING, SECTION 2-6-2**

BE IT ENACTED BY THE CITY COUNCIL OF SHUEYVILLE, IOWA:

Section 1. Purpose. Chapter 6 of the Code of Ordinances of the City of Shueyville, Iowa, is hereby amended by deleting the same and inserting in lieu thereof the following

Section 2. Adopted: The following Chapter 6 is hereby adopted as follows:

**CHAPTER 6 Posting**

**2-6-2 LISTING, LENGTH OF NOTICE.** The three public places where public notices of Ordinances and other matters permitted to be posted are to be displayed are:

1. Shuey's
2. City of Shueyville Website
3. Community Center

The City Clerk is hereby directed to promptly post notices of elections, Ordinances, and amendments, and to leave them so posted for not less than ten days after the first date of posing, and the City Clerk shall note the first date of such posing on the official copy of the Ordinance and in the official Ordinance book immediately following the Ordinance.

(Code of Iowa, Sec. 380.7)

On the 11<sup>th</sup> day of October, 2016, at a regular meeting of the Shueyville City Council, Shueyville, Iowa, Councilperson Neuhaus introduced Ordinance No. 105, and moved that it be given its first reading. The motion was seconded by Councilperson Frisk.
